Terms and Conditions

These Terms and Conditions ("Agreement") constitute a legally binding agreement between you ("User") and SuisseMont & Co ("we", "our", or "the Company"), governing your access to and use of the services offered via our platform located at [www.suissemont.com] (the "Platform"). By accessing or using the Platform, you agree to be bound by these Terms.

I. Eligibility

By using the Platform, you confirm that you are at least 18 years of age or the legal age in your jurisdiction and are legally capable of entering into binding contracts. You must not be a person barred from receiving financial services under the laws of any applicable jurisdiction.

II. Services

SuisseMont & Co provides access to a digital trading platform that enables trading in Contracts for Difference (CFDs), Digital Contracts (DC), Foreign Exchange (Forex), Commodities, Stocks, Indices, and Cryptocurrencies. We reserve the right to modify, suspend, or discontinue any part of the services at any time without prior notice.

III. Risk Disclosure

Trading financial instruments such as CFDs carries a high level of risk and may not be suitable for all investors. You may lose all or more than your initial investment. You acknowledge and accept that engaging in leveraged or margin-based products carries inherent volatility and risk, and you agree to trade solely at your own risk.

IV. Account Registration

To access the Platform, you must complete the account registration process by providing accurate, current, and complete personal and financial information. You are responsible for maintaining the confidentiality of your account credentials and for all activities that occur under your account.

V. User Obligations

You agree to use the Platform solely for lawful purposes. You shall not engage in any prohibited activities, including but not limited to market manipulation, fraud, unauthorized use of data, money laundering, or the financing of terrorism. Any violation may result in immediate termination of your account and legal action.

VI. Deposits and Withdrawals

All deposits and withdrawals must be conducted through the approved payment channels listed on the Platform. Processing times and transaction fees may vary depending on the method selected. You are responsible for understanding all applicable costs before initiating a transaction.

VII. Intellectual Property

All content, design, software, trademarks, and other intellectual property available on or through the Platform are the exclusive property of SuisseMont & Co and its licensors. You agree not to reproduce, distribute, modify, or exploit any part of the Platform without express written consent.

VIII. Funding and Withdrawals

Withdrawal requests are subject to compliance checks, account verification, trading activity review, and risk management protocols. In accordance with our capital controls and operational policy, a **minimum holding period** and **transaction threshold** may apply, depending on the client's account tier.

Clients will be notified via the Platform interface of any applicable conditions or restrictions before initiating a withdrawal. We reserve the right to request additional documentation or delay processing to ensure regulatory compliance and risk integrity.

IX. Limitation of Liability

To the maximum extent permitted by law, Suisseмонт & Co shall not be liable for any direct, indirect, incidental, special, or consequential damages arising out of or related to your use of the Platform. This includes, without limitation, damages resulting from system failures, delays, interruptions, data loss, or unauthorized access.

X. Termination

We reserve the right to suspend, restrict, or terminate your access to the Platform at our sole discretion, without prior notice, if we determine that you have violated these Terms or applicable laws and regulations. Upon termination, any outstanding obligations shall survive until fully discharged.

XI. Governing Law

This Agreement shall be governed and construed in accordance with the laws of the **United States of America**, without regard to conflicts of law principles. You agree to submit to the exclusive jurisdiction of the courts located within the United States for any dispute arising out of or relating to this Agreement.
